1. Speeding traffic

Richard Holden M.P. promised to help the Parish Council with the Speeding Traffic problem. He also mentioned a move towards the implementation of walking and cycling routes within County Durham.

2. Lights for the Village Green

Meter to be installed in the feeder box by E-On on 20th August. It is hoped to get funding to run the electricity cables under the road, to light the trees on the village green, from Weardale AAP. The Parish Council have been promised that all the necessary work will be done so that we will have lighting on the village green in time for Christmas.

10. Witton Word Grant

Councillor Shuttleworth has promised to give the Parish Council a grant of £1000 to help with the Witton Word running costs.
