56/21 Minutes of the Ordinary meeting held 10th May 2021.
Minutes agreed as being accurate and correct.

57/21 Matters arising from the previous minutes.

1. Speeding traffic

Councillor Parsons felt that any further correspondence to Durham County Council regarding this matter should be forwarded to the local County Councillors.

2. Village History Information Boards

Councillor Parsons updated Councillors about the history information boards, in his role as part of the Heritage Group, and asked whether Councillors would support its installation on the village green. Permission from Durham County Council is still required before the installation can be carried out.

It was resolved:

Councillors gave their support for the installation of the information board.

Councillor Parsons declared an interest in this matter.

3. Witton word

Councillors discussed the initial problems regarding the May 2021 issue of the Witton Word. It is hoped to get more advertisers which will help pay for printing costs.

It was resolved: It was agreed to try and improve the content of future issues by hopefully involving more organisations within the village. Councillors requested more time to proof read the next issue.

4. Village green / fence on the village green

Chairman has been in contact with Jill Errington from Durham County Council and was told that Durham County Council have the responsibility for the maintenance of the village green and any fences on it. The Parish Council can carry out works on the village green so long as it is "for the better enjoyment of residents."

5. Cars parked on Station Road

No further updates at this time.

6. Parish Council Facebook page

Councillors discussed better ways to communicate with residents using social media.

7. Christmas lights

No further updates at this time.

8. Witton le Wear Primary School

Councillors Docherty and Murray-Leslie made Councillors aware of the plans to improve the building facilities within the School. Two sheds have been demolished to make space for future developments.

Councillors Murray-Leslie and Docherty declared an interest in this matter

9. Electric car charging points

Councillor Wilson met with a representative from Durham County Council to discuss the positioning of an electric car charging point. It is part of the County Councils plans regarding carbon reduction.

10. Hanging baskets

Clerk has been in contact with Thinford Nurseries who have promised to provide the hanging baskets within the next couple of weeks.

11. Dog bins

Councillors discussed the continuing problem of dog bins in the village.

It was resolved: Clerk to contact the Clean and Green Team at Durham County Council and ask whether the Parish Council could provide a bigger bin to replace the one in St James Gardens. The one on Cemetery bank needs repairing.
